Fees;

All fees are due Aug. 10TH 2010. A \$15.00 fee will be charged for returned checks.

Exhibit space assignment & Allocation;

Exhibit space will be assigned based on the date the application is received. Event coordinators reserve the right to rearrange space as a result of changes in floor plan, space restriction, fire code etc.

Subletting Space;

Will not be permitted without prior consent of the event coordinator's.

Permits - Licenses - Taxes;**Permits & Licenses are not required.**

Will provide information when obtained.

Motorcycle & Trailer Sales;

Vendors selling vehicles or trailers, that require a title, are required to obtain a license from the state. Information is available upon request.

Security;

All vendor booths (except for food vendors) will be located inside. Rally coordinators will be present during show hours to assist with security needs. The exhibit halls will be closed and lock during non-Rally times. Exhibitors assume total and complete responsibility for any customer's motorcycle or accessories left in the Exhibitors care for service or installation during the show. Motorcycles cannot be left in the Exhibit hall over night.

Insurance;

Please contact your insurance agent to ensure you are covered during the show dates. Exhibitors agree to hold the exhibit hall owners, its' employees, GWRRA and the Colorado District harmless of any Claims, demands, damages and liability whatsoever by person or persons on account of damage to property, or injury or death of any person occurring upon or about your leased premises.

Sound Systems;

The use of sound systems is permissible provided they are not audible more than three (3) feet into the aisle or neighboring booths. Event coordinator's will have absolute control over this regulation and can require you discontinue the use of your sound system.

Exhibitor use of space;

The exhibitor is to make use of his/her space only. All installations, service and exhibits must be performed within their purchased booth space.

Exhibit Booth includes;

One (1) Table - 8ft. And Two (2) Chairs

Cancellation Policy - Refunds;

Cancellations in writing by Aug. 1st will receive a 50% refund, No refunds after Aug 10. (Refunds apply to booth fees only. A \$10.00 handling fee will charged).

Fire Regulations;

All exhibitors must comply with City, State Rules and Regulations.

Unoccupied Space;

Event coordinator's reserve the right to utilize all unoccupied space and may at their discretion rent the space of any vendor who has not paid their space fees by the due date.

Cleaning and Maintenance;

Exhibitors are responsible for the cleaning and maintenance of their booth. Facility maintenance will sweep only the space outside the vendor booths. Disposal of materials such as tires; oil etc. is the responsibility of the Exhibitor. The exhibitor must comply with all City, State, Federal and Facility disposal regulations.

Electric;

Will be provided by the facility.. The exhibitor must provide his/her own extension cords.
